Nomination Notice

ASA Airline Contract Committee (ACC) Member

Due to the election of current ASA ACC member Jason Munson to the position of ASA Airline Representative, AMFA Local 14 is now accepting nominations to fill his position for the remainder of his term—which will end at the January 2013 Regular Membership Meeting.

The duties of the ACC are described in Article IX of the Local 14 Bylaws.

Qualifications to hold Local office are detailed in the AMFA Constitution, Article XIX, Section 1 B as follows:

To be nominated, a member shall be in good standing, an active or active associate member, attended **fifty percent (50%) of regular Local meetings** held during the **last year**, six meetings total, **or** present to the Local Secretary a nominating petition containing signatures (valid as certified by the Local Secretary) of ten percent (10%) of the affected members in good standing in the Local (this petition must be submitted when nominations are accepted at the Local meeting), and have been free of all fines and assessments to the National and Local for the preceding twelve months prior to nomination (except for the first election after receiving charter). Members who are unable to attend a meeting because of verified illness, death in the family, vacation, official Association business, or because they **reside and work beyond a fifty mile radius of where the meeting is held** will be given credit for having attended that meeting for purposes of meeting the minimum attendance requirements.

Nomination forms are available on the Local 14 website—go to www.amfa14.org, drag your pointer over the *FORMS* tab at the top of the homepage, and select the item labeled *Local Officer Nomination Form* from the dropdown menu.

Nomination forms and petitions (if applicable) must be submitted to the Local 14 Secretary no later than **5:00 pm on December 21, 2011**—the day of the December regular membership meeting. Both the nomination form and nomination petition can be submitted in person, by fax or by post using the information in the letterhead at the top of this page. Nomination forms can also be submitted electronically by saving a copy to your desktop, completing the form, saving all changes, attaching it to an email and sending it to: secretary@amfa14.org. (Adobe Reader 8 or later is required to save changes to the form if submitting electronically.)

All nominees will be required to verify their candidacy by completing and returning a Willingness to Serve Form, which will be forwarded to each nominee following the close of the nomination period.

Information about the voting process, including the ballot package mailing date and the ballot count-date, will be announced following the close of the nomination period.
