ARTICLE IV: ELECTION OF LOCAL OFFICERS & REPRESENTATIVES

SECTION 1:

Nominations and elections shall be governed by the rules set forth in the AMFA Constitution, Article XI, Sections 1-5 and these bylaws.

All Local officers and representatives shall be elected for a term of two (2) years, unless otherwise specified in these bylaws. Local officers shall be elected for a two (2) year term on an odd/even basis as follows:

The offices of the President, Secretary, Safety & Standards Chairman, One Executive Officer At Large (*if required*), Area Representatives and one (1) position of each Local Shop Committee, will be elected on even numbered years.

The offices of Vice President, Treasurer, remaining Executive At Large (if required) and the Airline Representative, two (2) positions (if needed) on each Local Shop Committee will be elected on odd numbered years.

SECTION 2:

Nominations for all Local officers shall be called for at the first meeting in October and each Local shall elect the aforementioned officers by secret ballot vote of its membership at the first meeting in December. No member shall be entitled to hold more than one (1) office at the same time. Ballots cast for candidates not nominated in conformity with Local bylaws shall not be tabulated. Newly elected officers shall assume the duties of the office to which they were elected at the regular monthly meeting in January following their election in December as provided in the National Constitution. All Local election ballots will be mailed to the membership with stamped return envelopes.

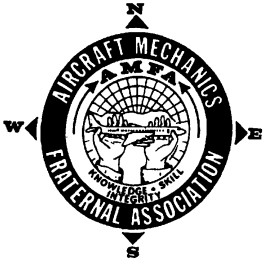

ARTICLE IV: ELECTION OF LOCAL OFFICERS AND REPRESENTATIVES SECTION 5:

To be nominated for any Local officer position except that of Airline Representative, a member shall be in good standing, an active or associate member, attended fifty percent (50%) of regular Local meetings held during the last year, six meetings total, or present to the Local Secretary a nominating petition containing signatures (valid as certified by the Local Secretary) of 10% of the members in good standing in the Local (this petition must be submitted when nominations are accepted at the Local meeting), and have been free of all fines and assessments to the National and Local for the preceding twelve months prior to nomination (except for the first election after receiving charter).

Members who are unable to attend a meeting because of verified illness, death in the family, vacation, official Association business, or because they reside and work beyond a fifty mile radius of where the meeting is held will be given credit for having attended that meeting for purposes of meeting the minimum attendance requirements (this proof must be submitted when nominations are accepted at the Local meeting).

Nominees for the position of Airline Representative are subject to the above criteria, but must have attended fifty percent (50%) of regular Local meetings held during the two years preceding nomination, twelve meetings total, reference National Constitution Article X Section 3(C).

Election Timeline

Nominations will be accepted thru the “Noon” October 21st 2009 General Membership Meeting

Letters of Acceptance will be sent out on October 23rd 2009.

Letters of acceptance will be returned to the “Local 14” office by November 6th 2009.

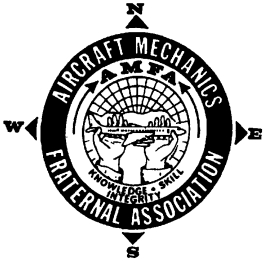
Ballot will be mailed on November 14th 2009.

Ballots must be returned by Noon on November 28th 2009 with counting to follow.

If a “Runoff Election” is required ballots will be mailed by December 4th 2009

“Runoff Ballots” are to be returned by Noon on December 15th 2009 with counting to follow.
